



Game terms and conditions

The organiser of the game is H-Budapest Kft. (seat: 1112 Budapest, Neszmélyi köz 3., incorporation no.: 01-09-679390), hereinafter: the Organiser.

Participants of the game automatically accept the Terms and Conditions written here without further legal act and accept its content as obligatory.

Participants of the game

Any internet user natural person over the age of 18 and with a Facebook profile can participate in the game (hereinafter: Participant), who over the course of the game participate voluntarily.

If the winner of the game is of restricted capacity, then they are entitled to administration regarding their prize only in the presence of their lawful representative. If the winner of the game is incapacitated, only their lawful representative is entitled to administration.

The following persons cannot participate in the game:

The owner, lead committee members, employees and agents of the Organiser and their close relatives (Ptk. (Hungarian Civil Code). 8:1. § (1) 1.);

Owners, lead committee members, employees and agents of companies directly contributing to the administration, and their close relatives.

Time period of game

The game is effective for a period between 00:00 May 3rd, 2018 – 18:00 June 9th, 2018

Participating in the Game, signing up to it is possible on the send-in deadline day until the time of day mentioned at the game of interest. Any sign-ups before the start of the game period or after the end of it, are invalid.

Signing up to the Game

Signing up to the Game is by downloading the roll.world application and scanning the QR code found on the Game's official website (<http://nyerj.openroadfest.hu/>) and making a photo and posting it public. Only those participants participate in the prize draw whose Facebook posts are active at 22:00 June 9th, 2018, meaning participants that will have not deleted their post or modified its category by then.

During the Game it is possible to win the prize with signing up to one promotion only but posting a photo for a single promotion entitles to a single chance for winning in the prize draw. Successfully signing up to multiple promotions means bigger chance for winning the prize. The promotions will be displayed by the Organiser at the game's website and/or at the 19. Harley-Davidson Open Road Fest, Participants already registered will receive message notification by the roll.world application.

Choosing and informing the winners

The winner will be selected by a draw after the Game ends, from Players who according to the Game conditions downloaded the application and posted one or more photos public with the roll.world application. Taking and public-posting one photo enrolls Players to the prize draw, participating in multiple promotions and taking and public-posting photos with them increases the chance for winning.

The draw takes place with a notary at the 19. Harley-Davidson Open Road Fest (Pelso Camping, 8226 Alsóörs, Füredi u. 1.) Main Stage, on 21:45 June 9th, 2018. The notary will prepare an official record of the draw. The Organiser will notify the winner through e-mail, Facebook message and/or the roll.world app within 48 hours from the draw about the acquiring of the prize. If the winner is on the site at the draw, they can come forward in person for the prize. The Organiser will disclose the name of the winner. The Organiser cannot be held responsible in case the Winner is unavailable to receive notification of their prize due to wrong or changed submitted data or if their accounts are unable to receive message of the prize.

Delivery of the prize

The prize will be handed over to the winners in person by the Organiser (at the seat of the Organiser, 1112 Budapest, Neszmélyi köz 3.).

The winner is obliged to cooperate in order for the receipt/utilization of the prize. If this is violated and the hand-over of the prize fails, it will not be possible to hand over or utilize the prize at later times and the Organiser will not be held responsible.

Data processing

With participation in the Game Participants accept their personal data to be used by the Organiser in a manner described by the Data Processing Policy. The data processing practice, the data processing claims entitled to the Participants and other data processing terms and conditions not mentioned in the present Game terms and conditions are communicated in the Organiser's Data Processing Policy.



Liability denial

The Organiser is not liable for the incompleteness of any registration or tender (incorrect name, address, fewer replies, etc.), late notification or late posting. The Participants are responsible for any consequence of incorrectly submitted data or the incapability of their mailboxes' message receipt. The Organisers generally have no means to check the validity of the submitted data at (or after) registering. Regarding this solely Participants may be held responsible and they bear all financial and legal consequences that may occur.

The Organiser denies all liability for compensation or reimbursement requests resulting from faults, shortcomings and malfunctioning of the Game; costs, damage, losses arising due to or resulting from delays during the Game, except for when denial of liability is legally forbidden by the Laws of Hungary. The Participant by participating in the game explicitly resigns from any enforcement of claims regarding the administration of the Game, the prize draw, the prizes or the winners, against the Organiser or any third parties.

The Organiser is not liable for the Game's accuracy, reliability, correct functioning, completeness and suitability for its purpose. The Game organised by the Organiser is not sponsored by any means by Facebook and is not connected to it in any way. The submitted data is handled by the Organiser.

The Organiser reserves the right to modify the present Game terms and conditions.

With accepting the Game terms and conditions, the Participant agrees to that they fully and without reservation acknowledged the participation requirements posed in the present Game terms and conditions.
